1. Introduction

All ships on international voyages, of 500 GT and above, flying the flag of an EU Member State or flying the flag of a third country when calling at a port or anchorage of an EU Member State, are required to have on board an IHM Part I.

After the approval of IHM Part I and the certification, the IHM should be properly maintained and updated throughout the operational life of the ship, reflecting new installations containing any hazardous materials and relevant changes in the structure and equipment of the ship.

The maintenance of the IHM is a key requirement of the EU SRR. The shipowner is responsible for the maintenance of IHM during the lifetime of the ship. Shipowners should establish the necessary procedures on board the ship and within their company to manage their long-term environmental responsibilities and should designate a person for maintaining and updating the IHM.

2. Scope of Document

VEDAM certifies that the maintenance of IHM Part 1 of this vessel from 01 Jan 2022 till 31 Dec 2022 is in conformity with the following regulations and guidelines:

- Regulation (EU) No 1257/2013 of the European Parliament and of the council of 20 November 2013 on ship recycling and amending regulation (EC) No 1013/2006 and Directive 2009/16/EC
- IMO MEPC.269(68) 2015 Guidelines for the development of the inventory of hazardous materials
- EMSA's Best Practice Guidance on the Inventory of Hazardous Materials.

3. IHM Maintenance Methodology

- A. Purchase orders are collected from Shipowner's Purchase department since Date of Statement of compliance.
- B. Segregation of purchase orders are done manually based on suppliers.
- C. Inquiry raised to suppliers for MD & SDoC documents.
- D. Software generated MD & SDoC will be sent to supplier in case:
 - 1. Received MD & SDoC not relates with Supplied Material.
 - 2. Supplier not reverting after second Follow up.
- E. Analysis is done by HazMat expert after receipt of MD & SDoC.
- F. MD & SDoC uploaded to Software after Analysis.
- G. Yearly report generation from IHM Maintenance software
